



PSYC 700 Psychiatry Research

Elective Description

This elective allows a student to conduct research in the area of Psychiatry under the direction of a faculty member or preceptor.

Credit: 4-8 credits

Prerequisite: Permission of the sponsoring faculty member or preceptor and approval by the Sr. Associate Dean for Clinical Clerkships.

Elective Structure: Schedules are dependent on project and established between the student and faculty member or preceptor. The expectation is that students dedicate full-time efforts to the project.

Entrustable Professional Activities

As a fourth-year student, the focus of skills development are those tasks important for entering residency training:

- Gather a history and perform a physical exam
- Prioritize a differential diagnosis following a clinical encounter
- Recommend and interpret common diagnostic and screening tests
- Enter and discuss orders and prescriptions
- Document a clinical encounter in the patient record
- Provide an oral presentation of a clinical encounter
- Form clinical questions and retrieve evidence to advance patient care
- Give or receive a patient handover to transition care responsibility
- Collaborate as a member of an inter-professional team
- Recognize a patient requiring urgent or emergent care and initiate evaluation and management
- Obtain informed consent for tests and/or procedures
- Perform general procedures of a physician
- Identify systems failures and contribute to a culture of safety and improvement

General Clerkship Objectives

Medical Knowledge

- Develop a hypothesis-driven project or understand the relevance of a hypothesis drive question.
- Pursue a question with objectives designed to reach answers or new questions.

Interpersonal and Communication Skills

- To demonstrate critical thinking about data and outcomes with research team.

Practice-Based Learning and Improvement

- Develop an awareness of the parallel importance of the choice of methods to answer research questions in clinical practice.

Evaluation

The evaluation will include the entrustable professional activities, primarily EPAs 9 and 12. The clerkship preceptor will evaluate those relevant to this clerkship experience.

Each student should submit a summary report of progress and data to date during the last week of the elective to the Associate Dean for Academic Affairs.

This elective is graded Satisfactory/Unsatisfactory.
